(over 35 years of age)

GENERAL INFORMATION

Vermont Farm Bureau annually conducts an Outstanding Farmer Award program. Selection of the winning farmer (farm family) is based on efforts in both the chosen occupation and leadership achievement.

ELIGIBILITY

CONTESTANTS MUST MEET THE FOLLOWING CRITERIA TO COMPETE:

1. Member(s) in good standing with their County Farm Bureau
2. Actively engaged in farming, with the majority of income coming from production agriculture.

Each county may submit one entry to be considered for state recognition.

Additional space, other than that available on the entry form, may be used. Scrapbook or other visual additions and letters of recommendation may be submitted for consideration in judging. We will attempt to return all materials, but do not take responsibility for photos, etc. lost in the mail. We recommend sending only copies of photos and mementos.

JUDGING

A panel of qualified judges will select the state winners. The application and entry form of each county winner will be coded upon receipt by the VFB office. Applicants' names and counties will not be revealed to the judges until after the final selection has been determined.

Complete applications must be received by the Vermont Farm Bureau office by October 1, 2018.
